MEETINGS

Commissioners held Fuerst Ditch #734 Hearing-Logan County Engineer Scott Coleman, Engineer Office Michael Kerns, Engineer Office Jonathan Parthemore and Doug Putman Citizen were in attendance. Engineer Scott Coleman explained the ditch was constructed in 1974, \$2,800 was the construction assessment base used for the reconstruction of the 650 ft of tile. Logan County Engineer office has continued to maintain this ditch using the original assessment base amount, it is no longer possible to do so. ORC allows for the engineer to review such projects every six years and to add to the schedule of benefited owners any other owner who in the judgement of the board, is benefited by the operation and maintenance of the improvement and to reestablish the permanent assessment base to reflect what it cost to reconstruct the entire ditch in 2022.

Logn County Engineer Scott Coleman determined the new construction base cost for the project should be \$16,700.74. Up to 20% of this updated permanent assessment base can be used to reimburse the maintenance account to allow for sufficient funds to perform maintenance and repairs. The Fuerst Ditch #734 account would never have a balance total of mor than \$3,340.15. Logan County Engineer Scott Coleman recommend the Boad of Commissioners increase the permanent assessment base to \$16,700.14 and recommend that 10% of the proposed reestablished base be set as the annual assessment percentage.

Mr. Putman voiced his concerns of no maintenance being done to the ditch since 1995. Question the balance currently in the account now. Requested expenses on the ditch since 1974. Engineer office will provide the information Mr. Putman has requested.

Commissioners discussed the 10% annual assessment percentage. Commissioner Benedetti proposed percentage be reduced to 5% of the \$16,700.74. Engineer Scott Colman indicated 5% would be sufficient to maintain.

After further discussion Commissioner Paul Benedetti moved; Commissioner Joe Antram seconded to move the annual assessment percentage be decreased from 10% to 5% of the 416,700.74 on 2023 tax bill and accepted the updated landowner's assessment schedule.
