RE: ADOPT PERMIT FEES FOR SPECIAL PURPOSE FLOOD DAMAGE REDUCTION REGULATIONS – BUILDING DEPARTMENT

WHEREAS, public hearings were held on February 8, 2011 and February 10, 2011 for public comments on the new flood damage reduction regulations permit fees, and

WHEREAS, the attendance sheet for those hearings is attached hereto, and there were no comments from the public either in opposition or in support of the permit fees,

FLOOD DAMAGE REDUCTION REGULATION APPROVAL and PERMIT FEES LOGAN COUNTY, OHIO

These fees apply to all work, development, alteration, construction or creation to or within flood hazard areas cited in the regulations of the Special Purpose Flood Damage Reduction Resolution of Logan County, Ohio. All fees shall be made payable to the Logan County Building Authority.

DEVELOPMENT – SUBDIVISIONS or Partial/Phased Subdivision Review (excludes structures).

\$50.00 plus - \$10.00 per affected acre (or partial acre) OR; \$10.00 per lot, whichever is the larger.

DEVELOPMENT - EXCAVATION/FILLING/CHANNELING only

\$50.00 plus - \$10.00 per affected acre (or partial acre) OR; \$10.00 per lot, whichever is the larger.

DEVELOPMENT - CONSTRUCTION/STRUCTURES

\$ 50.00 per parcel, where construction occurs.

- 1. Fees shall be paid at the time of submittal. In the event that the acreage or lot fee is more than presented to this office, the additional fee shall be paid prior to approval of the project and issuance of the permit.
- 2. Owners or developers shall be charged for any additional costs incurred by the Logan County Building Authority resulting from incorrect, insufficient or revised information of the intended work.
- 3. The listed fees do not include any additional charges should they be incurred as a result of any State or Federal requirement.
- 4. Fees shall be doubled if approval of the project and issuance of a permit are not obtained from the Logan County Building Authority prior to the start of work or construction.
- 5. All fees paid are non-refundable.
